FESTIVAL INFORMATION AND RULES FOR 2026

TIME AND LOCATION:

- >The festival will be held in the Downtown Plaza and adjacent areas on Saturday October 3, 2026, from 9:00 AM to 5:00 PM.
- >**Setup time is from 4:00 AM until 8:00 AM on Saturday, October 3, 2026. Streets must be cleared of all vehicles as soon as merchandise can be unloaded but no later than 8:00 AM.**
- >Take down time is from 5:00 PM until 7:00 PM that same day.
- >Vendors must remain for the duration of the festival. Absolutely no vehicles will be allowed to Delmas Avenue, Canty Street, Magnolia Street, or Watts Avenue after initial setup.

OUTSIDE FESTIVAL * WEATHER WILL DETERMINE CANCELLATION *** NO REFUNDS**

- >A vendor is any individual, club, church, sorority or business selling goods at the Zonta Arts and Crafts Festival.
- >**Booth Spaces CANNOT BE RE-RENTED OR SOLD BY VENDOR. If the vendor whose application is accepted by Zonta is unable to attend, space reverts to ZONTA.**
- >Vendor fee (**postmarked by August 31, 2026**) will be \$125.00 per vendor space
- >ALL food booth applications (**postmarked by August 31, 2026**) will be \$140.00 per 10x15 space or \$200 per 10x20 space.
- >**ALL applications postmarked AFTER August 31, 2026, will be \$150.00 per space, craft or \$160.00 food booths and Food Trucks will be \$200.00**
- >**FINAL REGISTRATION DEADLINE IS SEPTEMBER 15, 2026. Applications postmarked after September 15th will not be accepted and vendors will be notified.**
- >**Money will NOT be refunded for cancellations received after September 1st, 2026.**
- >Notification of cancellation will be greatly appreciated.
- >Space assignments will be made on a first come basis.
- >Vendors will be notified of space assignments by email or mail before the festival. If you register between September 1st and September 15th and have no email address, you will need to pick up your packet at the Information Booth the day of the festival.
- >Any vendor deemed inappropriate for the show by the Arts & Crafts Chairperson may be asked to leave.

FOOD:

- >**Food (for immediate consumption) cannot be sold from the same booth as arts and crafts.**
- >**Food Vendor Compliance Agreement:**

All food vendors are required to comply with Mississippi state and local health regulations, including obtaining any necessary food service permits. While proof of permit is not required with this application, by submitting this form, you affirm that you will obtain and maintain all required permits and operate in full compliance with applicable laws.

- >Food exhibitors must provide their own fuel source.
- >Garbage remaining after the Festival must be bagged.

VENDOR COMPLIANCE STATEMENT:

All vendors are required to comply with all applicable federal, state, and local laws, regulations, ordinances, and permitting requirements. It is the sole responsibility of each vendor to obtain and maintain any licenses or permits necessary for their operation. By submitting this application, the vendor agrees to operate in full compliance and understands that failure to do so may result in removal from the event and/or further action.

SPACE:

>Size of the space shall be approximately 10' x 12' for Arts and Crafts displays and 10' x 15' for Food Booths and 10' x 20' for Food Trucks. Some adjustments will be made this year to space locations, so spaces may be shifted slightly.

>The festival is outdoors with some spots partially shaded. The majority are in full sun on concrete.

PROMOTION:

>The number of vendors expected to participate is approximately 250.

>A significant turnout is anticipated, with large crowds expected throughout the event.

>ZONTA will advertise this Festival in local, state, and regional media.

SETUP/LOADING:

>No equipment is provided. Tables, chairs, screens and canopies are the responsibility of the vendor.

>Loading and unloading is the responsibility of the vendor. Vendors will park in designated parking lots.

>Only 110 volts of electricity is available on a very limited basis. **We can not guarantee that you will be able to access electricity.**

>If you need electricity, please bring a 100 ft heavy duty extension cord and/or a silent generator.

SECURITY:>Law enforcement officials will be present for the duration of the festival.

SPECIAL REGULATIONS AND PRECAUTIONS:

>Mississippi Law requires collection of MS state Tax of 7% by exhibitors and 9% for all FOOD for immediate consumption sold.

>Vendors must remain with and are responsible for their booth except for breaks and errands. During those times, someone must be specified to stay with the merchandise. ZONTA is not responsible for any items lost, stolen or broken.

>INVERTER" (quiet) GENERATORS ARE ALLOWED IN ALL BOOTHS. (If your generator is too loud, Zonta reserves the right to have the generator disconnected).

Zonta Club of Pascagoula Area shall not be responsible or liable for any injury or loss that may arise or come to lessee, or his/her employees or goods, for any cause whatsoever. Zonta Club of Pascagoula Area does not provide insurance for vendors. Vendor relieves Zonta Club of Pascagoula Area and the property owners of responsibility in connection with the safekeeping of property during the festival.

NO ALCOHOLIC BEVERAGES OR FIREARMS ALLOWED
